**REPORT OF THE SCRUTINEERS ON THE POLL HELD ON
APRIL 10, 2015 AT THE COURT CONVENEED MEETING OF THE
EQUITY SHAREHOLDERS SEEKING APPROVAL TO THE SCHEME**

Dear Sir,

We, Nilesh Shah, a practicing Company Secretary and Rajesh Tiwari, a equity shareholder of the Applicant Company, appointed as Scrutineers for the purpose of the poll taken on the resolution seeking equity shareholders' approval to the Scheme of Amalgamation between Shasun Pharmaceuticals Limited (Transferor Company) and Strides Arcolab Limited (Transferee Company) and their respective shareholders and creditors, at the court convened meeting of the equity shareholders of Strides Arcolab Limited, held on Friday 10th April, 2015 at 12:00 noon (1200 hours) at The Regenza by Tunga, Plot No. 37, Sector 30-A, Vashi, Navi Mumbai 400703, submit our report as under:

1. The empty ballot boxes kept for polling were duly inspected by the equity shareholders present.
2. After the time fixed for closing of the poll by the Chairman, 2 (two) ballot boxes kept for polling were locked and sealed in our presence with due identification mark placed by us.
3. The locked and sealed ballot boxes were subsequently opened in our presence together with 2 (two) witnesses and the poll papers were diligently scrutinized. The poll papers were scrutinized and reconciled

with the records maintained by the Registrar and Transfer Agent of the Company and the authorizations /proxies lodged with the Company.

4. The poll papers, which were incomplete and/or which were otherwise found defective have been treated as invalid and kept separately.
5. 241 equity shareholders holding 29,009,424 equity shares attended the meeting in person or by authorised representative or by proxy. . Out of the said 241 equity shareholders, 212 equity shareholders holding 28,256,760 equity shares present in person or by proxy or by authorized representatives cast their votes.
6. The result of the Poll seeking approval to the Scheme of Amalgamation who voted in the meeting is as under:

“RESOLVED THAT pursuant to the provisions of Sections 391 to 394 and other applicable provisions of the Companies Act, 1956 and/ or under the corresponding provisions of the Companies Act, 2013, the rules, circulars and notifications thereunder (including any statutory modification or re-enactment thereof) as may be applicable, the Securities and Exchange Board of India Circular No. CIR/CFD/DIL/5/2013 dated February 4, 2013 read with Circular No. CIR/CFD/DIL/8/2013 dated May 21, 2013, the observation letters issued by each of BSE Limited and the National Stock Exchange of India Limited dated December 10, 2014 and December 11, 2014, and relevant provisions of applicable laws, and subject to the approval of the High Court of Judicature at Bombay and the High Court of Judicature at Madras, the Scheme of Amalgamation (the “Scheme”), between Shasun Pharmaceuticals Limited (the “Transferor Company”) and Strides Arcolab Limited (the “Transferee Company”) and their respective shareholders and creditors, for the Transferor Company to be amalgamated with the Transferee Company, be and is hereby approved and agreed to, with/ without any modifications and/ or conditions, if any,

which may be required and/ or imposed by the High Court of Judicature at Bombay and/ or the High Court of Judicature at Madras while sanctioning the Scheme, or by any other authorities under applicable law.

“RESOLVED FURTHER THAT for the purpose of giving effect to the above resolution and for removal of any difficulties or doubts, the Board of Directors of the Transferee Company (herein referred to as the “Board”, which term shall be deemed to include any committee or any person(s) which the Board may constitute or nominate to exercise its powers, including the powers conferred under this resolution), be and is hereby authorized to do all such acts, deeds, matters and things as it may, in its absolute discretion, deem necessary, expedient, usual or proper, and to settle any questions or difficulties or doubts that may arise, including passing of such accounting entries and/ or making such adjustments in the books of accounts as considered necessary to give effect to the above resolution, or to carry out such modifications/ directions as may be required and/or imposed by the High Court of Judicature at Bombay and/ or the High Court of Judicature at Madras while sanctioning the Scheme, or by any other authorities under applicable law.”


