Strides Shasun receives USFDA Approval for Acetazolamide Tablets

Ltd. has received approval from the United States Food & Drug Administration (USFDA) for **Acetazolamide Tablets USP, 125 mg and 250 mg.**, a generic version of *Diamox Tablets®*.
