This caution notice is issued on behalf of Strides Pharma Science Limited (CIN: L24230MH1990PLC057062) having its Registered Office at 201, Devavrata, Sector 17, Vashi, Navi Mumbai - 400 703 (hereinafter referred to as the '**Strides**').

The general public is hereby cautioned that certain unknown individuals / entities have been trying to mislead the public by wrongfully representing that Strides has:

- Invested / agreed to invest in Artmed Healthcare Private Limited (CIN: U74999TG2016PTC110459) having their Registered Office at Door no. 1 - 100/ 1/ CCH, Nallagandla Village, Serilingampally, Hyderabad – 500 019 (hereinafter referred to as 'Artmed'); and
- Donated / agreed to donate an amount of INR 60 crores to Jeevan Jyot Cancer Relief & Care Trust (Trust Registration No. E-17259) having its Office at 3/9, Kondaji Chawl, Jerbai Wadia Road, Parel, Mumbai – 400 012 (hereinafter referred to as 'Jeevan Jyot Trust')

Strides has also come across forged documents including a board resolution, certificate of inward remittance in Form 10H for credit of amount in favour of Artmed and a disclaimer letter indicating donation to Jeevan Jyot Trust, being circulated amongst the Public to substantiate the above.

Please note that this is entirely a fraudulent claim/ activity and Strides has neither taken a decision to invest/ donate in Artmed/ Jeevan Jyot Trust and the documents being circulated as evidence for such investment is forged and the whole exercise is a scheme to perpetuate fraud. Strides has also filed a Police complaint in appropriate jurisdiction and an investigation is currently underway.

Strides strongly recommends that no one should respond to such solicitations, and we will not accept any liability whatsoever for any loss that the general public may incur owing to their investment decisions made based on forged documents produced by these unknown individuals / entities.
